GARBAGE AND RUBBISH COLLECTION LICENSE RENEWAL

The City of Willard's Code, Chapter 955 reads in part: **"No person shall engage in the business of collecting and/or disposal of garbage or rubbish for hire within the City without first obtaining a license."**

The City will be striving to enforce this. In the past, companies that provided rubbish collection at various times with dumpsters had often been missed. We will be looking for these.

To make the licensing process easier, I have enclosed a revised application form for your review. You may then complete the form, attach a check for the appropriate amount and return all to me for processing by January 1st.

Please remember to include your current residential rate schedule, if applicable. If you are a contractor that engages in commercial accounts, **only**, please also indicate that fact.
